Annual Report to the Kirk Nate Phillips, Senior Pastor / Head of Staff March 2021

A group of blind men heard that a strange animal, called an elephant, had been brought to the town, but none of them were aware of its shape and form. Out of curiosity, they said: "We must inspect and know it by touch, of which we are capable". So, they sought it out, and when they found it they groped about it. The first person, whose hand landed on the trunk, said, "This being is like a thick snake". For another one whose hand reached its ear, it seemed like a kind of fan. As for another person, whose hand was upon its leg, said, the elephant is a pillar like a tree-trunk. The blind man who placed his hand upon its side said the elephant, "is a wall". Another who felt its tail, described it as a rope. The last felt its tusk, stating the elephant is that which is hard, smooth and like a spear."

This ancient Indian parable about the blind men and the elephant can teach us a great number of things. It can remind us that our limited point of view, while valuable, might not provide the absolute truth we might think it does. It can offer a warning for those that are prone to quarrel - there may be more to the story. But I prefer to think of it in a positive way - as an encouragement to be in community.

Through our combined lenses, we can better appreciate what's real.

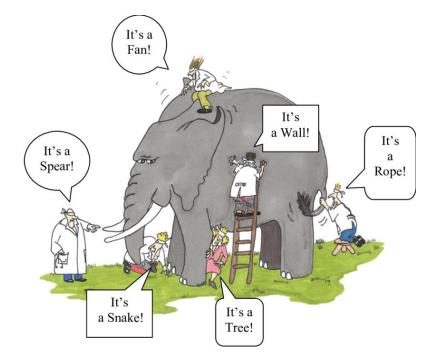

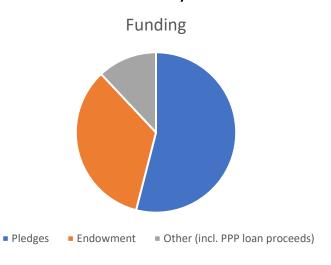

Investment and Endowment Information

- Our investments are managed by a professional management company, SEI Investments, selected
 by the Board of Trustees in 2011 and evaluated and selected again in 2016. The Investment
 Committee of the Board meets at least quarterly with the management company to review the
 performance of the portfolio.
- The use of the Endowments is governed by the Session of the Kirk, supported by recommendations of the Board of Trustees. Written policies govern both the Investments and the Endowments.
- The funds are invested in a mix of assets based upon the recommendation of SEI with the
 oversight and approval of the Investment Committee of the Board of Trustees. These investments
 generated combined realized/unrealized gains of \$1,729,571 in 2020. For the three years ended
 December 31, 2020, the funds returned an average of 2.67%.
- In 2019, the Investment Committee recommended a change in the withdrawal rate of the Endowment Funds, from 5% to 4.75% per year of a calculated average, in order to prolong the life of the investments. This recommendation was approved by the Board of Trustees and Session in 2019. The ultimate objective is to reduce the annual withdrawal rate to 4%, which is in line with other non-profit Endowments and will keep the funds "generationally neutral" meaning that the Kirk will reap the benefits of the invested funds for many generations to come.

In addition to the 2020 Operating Budget Support of \$1,172,994 from Kirk Endowments, an additional \$42,726 was withdrawn from Endowments and Special Funds for non-budgeted items as follows:

- \$25,029 from the Ann Redner beguest for the new Audio/Video installation in the refectory
- \$7,155 from the Capital Campaign fund for Acoustic improvements in the sanctuary
- \$8,212 from the Columbarium Expense fund for expenses related to interment costs
- \$1,900 from the Bells of Blessing Fund for repairs to the bells
- \$430 from the Bible Fund to purchase Bibles

Receipts to the Endowments

The Kirk received no bequests or special gifts into the Endowment Fund in 2020

Other funds totaling \$63,655 were received into the Endowments as follows:

- \$36,500 to the Columbarium Maintenance Fund from the sales of niches (net of returns)
- \$22,070 to the Facilities Fund from mortgage interest from three mortgages the Kirk holds
- \$5,085 to the Columbarium Prepaid Expense Special Fund

Excerpts from Pastor Nate's "State of the Kirk" address.

Worship

This year our worship experience was delivered, predominantly, through the Internet.

Our music program continued with "in person" drive in carillon concerts on a weekly basis. The classic car, Halloween, and Carols on the Carillon events were fantastic and creative. The devotional and quiet Vespers services that Glenn Miller put together gave stillness to our souls in the midst of great disruption. And, again, under Glenn's leadership the musicians diligently prepared rerecorded choral and solo music for worship and musical moments involving not only the Chancel Choir staff singers but also for special occasions involving the Girls' and Boys' Choirs.

If you haven't seen what they put together for our Mother's Day service, you really are missing something special.

Our online services, with the music, preaching, readings, and prayer, have been a lifeline for so many people in this time. While I cannot wait until we have the chance to meet again in person, the work we have done to establish this online platform did not happen overnight and from all of this, our reach has been exponential.

In the first few Sundays of the pandemic, we celebrated Palm Sunday and Easter. There was no procession of the palms and no Easter egg dash on the front lawn.

But between Facebook and the website, 842 people worshiped with us on Palm Sunday and a whopping 1,700 people from all over the country and world worshiped with us on Easter morning, which matched and exceeded the in-person attendances we had in 2019. The total number of all-time views for Easter was 2,779.

Even as we did our best to accommodate in-person services, using our garden service to our full advantage in the summer and deep into the fall and establishing a slick registration system to open up the sanctuary whenever we could, we saw a strong community of worshipers gathered together online week in and week out.

This was happening all year long. We had a total of 14,332 unique viewers this year in 22 countries, in December alone we had 3,878 people visit our website, and our email list grew by 154 people this year.

Mission

This outward facing response to the greatest challenge of our lifetimes was congruent to the first few words of our vision statement. We envision a world. Not just a church, a world. Jesus had an expansive vision for his message, not one confined to his most immediate followers. We are blessed to be a blessing.

And on we went, throughout the course of the year. We raised almost forty thousand dollars for our Covid Relief Fund and gave generously to support first responders, back to school efforts, and Presbyterian Villages of Michigan.

We even joined forces with Pontiac Community Foundation to offer ten \$1,000 gifts to small businesses in Pontiac suffering from the pandemic.

We raised thousands of dollars to relieve medical debt in the City of Pontiac. Our initial goal was to eliminate \$2.8 million in debt. I am pleased to report that, with the help of RIP Medical Debt that purchases the debt, we were able to eliminate - instead of \$2.8 million - almost \$5.5 million dollars of debt for over 5,000 families in Pontiac and Oakland County at an average of \$1,070 each.

Then, in September, under the leadership of Bobi Tallinger, Bob Heuer, Sheri Falvay, and Ann Manning, we participated in a modified version of the Crop Walk.

Usually the fundraising and recruitment for this effort to end world hunger relies on a heavy push during our "back to church" season. But, even at a distance, the Kirk won the coveted "shoe" trophy as the most generous participating church in the area with a record setting \$18,495 in donations.

The Adopt-a-Family Christmas program followed suit. The Kirk always responds when the deacons make their annual appeal to help families in need. In 2016, the church gave \$21,590, in 2017, \$22,805, and in 2018 \$24,198. But this year, in a year when we couldn't worship in the same space, where we haven't seen each other much since last March, this church contributed \$29,105.

And, oh by the way, our toy collection for Angel Tree? It took a last-minute push, but we collected almost 900 toys for Care House and Micah 6 in Pontiac, up from 700 last year.

Even with all of this outpouring of financial support, I am probably most proud of our annual service challenge. This initiative, birthed by our beloved Pastor Fernando that we wish so well in his new role in Denver, was handled so ably by Julie Walker. She continued in our tradition of catalyzing churches in the effort, going from six last year to partnering with nine churches this year with a total of 8,423 hours of service in the month of November.

Formation

This year we have been made especially grateful for Pastor Angela's dedication to this endeavor. She created an online formation universe where we connected with one another and the scriptures over zoom - with offerings almost every day of the week. She organized and created video and written devotionals for Lent, for this fall during the Made Well series, and for during Advent. If ever anyone doubted the importance of small group and bible study ministry, know that it was a lifeline for many this year.

And it wasn't only with one another, we journeyed all over the world - from Asia, to Israel, to Africa - to learn about the faith and make new friends with Christians going through all of this with us. We also had a summer writer's conference featuring best-selling authors that boasted sixty participants from five different churches.

She also picked up where Kecelyn left off with children's ministry.

Beyond organizing weekly Zoom Sunday school, she drew our children and families together for "Back to School" and "Thanksgiving" prayers and created an outdoor Christmas Eve service for the children with live nativity.

The wellbeing of faith formation in children and youth is always going to be a high priority for us here at the Kirk. Which is why we were so focused on finding an excellent youth pastor this year. And we did! And it was such a joy to experience an ordination and installation in November.

Pastor Kelsey and her husband, Mike, joined us this summer as a result of a national search led by Anita Pinson and her nominating committee. Upon arrival, Kelsey immediately went to work building relationships with the youth, even with the limitations of the pandemic. She created the "Kirk Campfire" which is located off the refectory near the lake - where youth met regularly for study and fellowship.

She led a Covid-safe retreat where youth and leaders imagined a new program called "The Oasis" which will provide programming and space for youth as they counter their stress with the practices of faith. But, let's face it, her greatest accomplishment so far to pull off one of the finest virtual Christmas pageants you will ever see!
